4	The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 pm 2082/11/05 BS (17/02/2026 AD) for SQ at the office of Bhairahawa,Rupandehi . Bids must be valid for a period of 45 day for SQ after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of above mention which shall be valid for 30 days beyond the validity period of the bid (ie.75 days)
