6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 pm 2082/02/12 BS (26/05/2025 AD) for SQ at the office of Bhairahawa,Rupandehi . Bids must be valid for a period of 45 day for SQ after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of above mention which shall be valid for 30 days beyond the validity period of the bid (ie.75 days )						
7. If the last date of Pre-Bid meeting/purchasing/submission day falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
